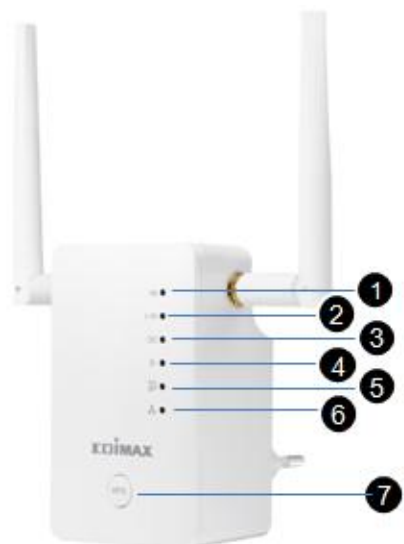

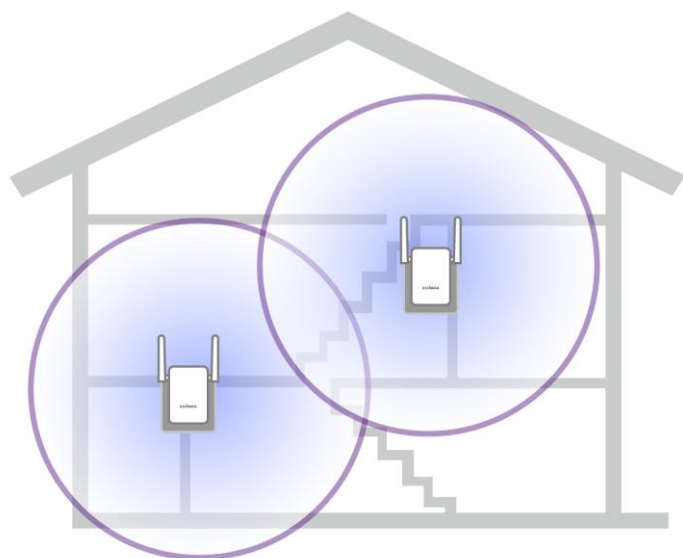

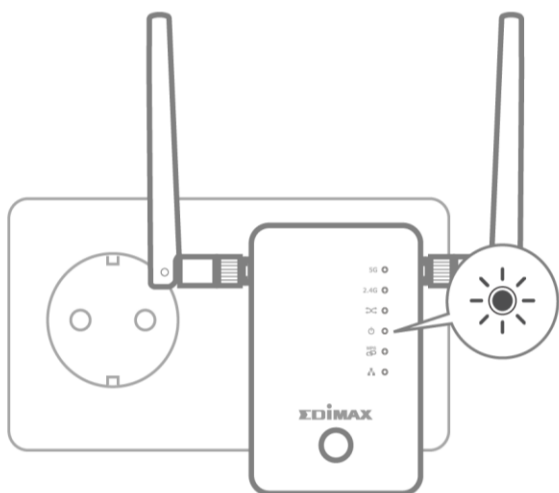

1. Nezobrazuje se přihlašovací stránka po zadání <http://edimaxext.setup> v prohlizeči, co mám dělat?

O: Chcete-li situaci napravit, *vyskoušejte některou s následujících metod:*

- Ujistěte se, že je počítač připojen k bezdrátové síti RE11S.
- Ujistěte se, že je počítač nakonfigurován na "Získat IP adresu ze serveru DHCP automaticky" a "Získat adresu serveru DNS automaticky".

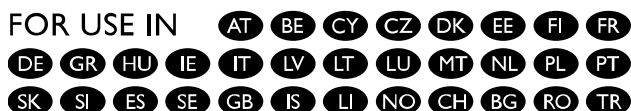
