

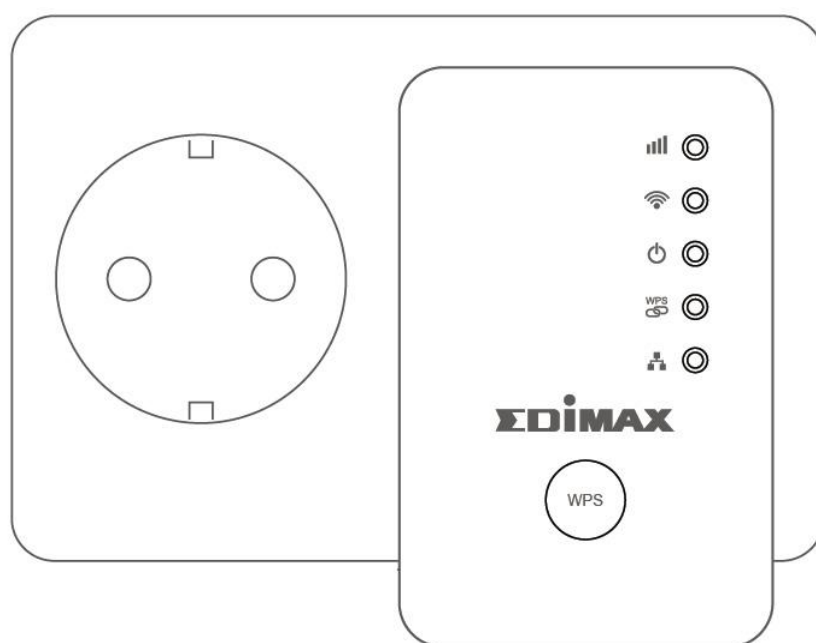

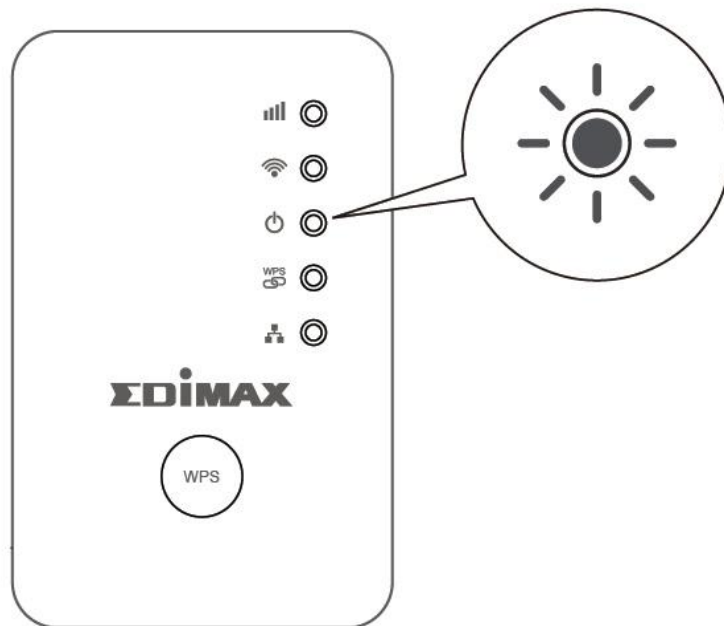
EW-7438RPn Mini má tři různé režimy práce:

III. Reset Extendeu

Pokud zaznamenáte problémy s vaším extenderem nebo chcete změnit režim práce, můžete jej resetovat do továrních nastavení. To vrátí všechna nastavení na výchozí hodnoty.

1. Stiskněte a držte tlačítko WPS/Reset alespoň 10 sekund, dokud nezačne blikat **zelená dioda napájení**.




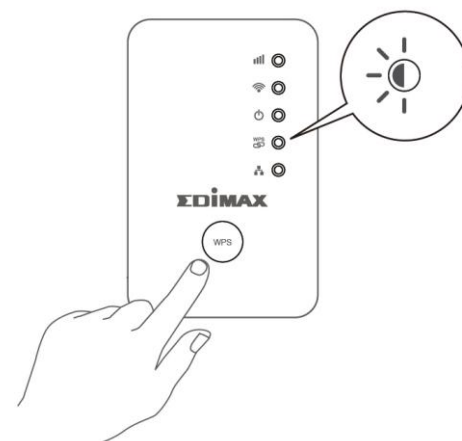
2. Vyčkejte, dokud se extender nerestartuje. Bude připraven pro nastavení, jakmile bude dioda napájení svítit **zeleně**.

IV. WPS

Pokud váš bezdrátový router/access point podporuje WPS (Wi-Fi Protected Setup), můžete použít tuto metodu pro nastavení bezdrátového extenderu.
